In 2010, RMH Houston named Mrs. Denny Volunteer of the Year. Today, she is actively involved on the boards of the Woman's Club of Bryan, Friends of the Sterling C. Evans Library, and MSC OPUS.

**Bruce Dickson** is the chief real estate officer for Forestar Group, an Austin-based real estate and natural resources company. He has spent much of his career in the homebuilding business as well as various positions in the financial services industry. Mr. Dickson previously served on the RMHC CTX Board from 1999-2005, serving as board president in 2004 and 2005. He currently serves on the Board of Trustees at Westlake Hills Presbyterian Church.

Allen Harrison joined St. David's Healthcare as chief executive officer of St. David's North Austin Medical Center in 2011. Prior to this position, Mr. Harrison served as chief operating officer and oversaw many departments at Presbyterian/St. Lukes in Denver. He is a 2010 alumnus of Leadership Denver through the Denver Metro Chamber of Commerce and serves on the boards of two non-profit organizations.

**Tala Matchett** is the director of business development for Hoar Construction where she is responsible for identifying and securing new project opportunities in central and west Texas. She is also responsible for spearheading community engagement for all Hoar Construction offices nationwide. Ms. Matchett has chaired various events at her children's school and is currently serving as RMHC CTX's 26<sup>th</sup> annual Bandana Ball Chair. Collectively, Becki, her brother Allen Benton and their parents own 20 McDonald's restaurants in the Austin area. They are frequent volunteers at the House, cooking meals for families and are RMHC CTX room sponsors.

**Dr. Mark Shen** was named president of Dell Children's Medical Center in February 2014, becoming the first physician to lead a Seton hospital. Prior to that position, Dr. Shen directed the pediatric hospitalist group Pediatric Consultation and Referral Service at Dell Children's Medical Center from 2007 to 2013. He helped develop Children's Comprehensive Care, a pilot clinic for the most medically complex children in Central Texas. Dr. Shen has longstanding interests in medical education and clinical quality and has been active both regionally and nationally in pediatric hospital medicine in a variety of committee and editorial roles.

Anne Meinig Smalling is president of HM International, LLC (HMI). Mrs. Smalling serves as the Chairman of the Board of Directors of Quality Sausage Company, American Innovations, and rateGenius.
